Welcome

We have an excellent health system in Switzerland and medical care is in most cases accessible for everyone according to their needs. However, barriers exist. We know that regarding care for patients with hepatitis B or C, some people get lost on the way from diagnosis to treatment and cure.

On the same time, diagnostics and therapies make great progress: Testing at the point of care with capillary blood or saliva and with results within a few minutes allows a rapid diagnosis and linkage to care. Integrated care, where all services are offered under one roof, improves treatment uptake. And last but not least treatment regimens for hepatitis C are much simpler today than a few years ago with shorter durations, less side effects and higher cure rates. Also for hepatitis B, more effective therapies are available.

These developments make it easier for patients to go through the cascade of care. In order for these "simplifications" to be effective in Switzerland, innovations in diagnostics have to be approved and reimbursed. And we have to discuss how we can simplify treatment guidelines, expand integrated services offer, streamline processes and how we better involve primary care takers in viral hepatitis care.

We are looking forward to hearing about experiences in Scotland, in Australia and in Switzerland in simplifying and streamlining care for viral hepatitis patients. We hope you will join us!
